




Despite a global pandemic and economic uncertainty, TKF weathered the last half of FY 2020 with minimal disruption in overall Total Net Revenue.

• Year over Year (Y-o-Y) growth rates by Revenue source have shown significant variance from 2016 to 2019

• General Donations Income growth rates only include: Individual Giving, Major Donors, and Board Donations (not including other sources)

• Events decrease driven primarily from Spring Soiree (coming off of a banner year \$292K in 2019). 2020 actuals were \$247K, but net revenue was up by more than \$50,000 over 2019

• General Donations up from previous year – Honor/Memorial Contributions and Major Gifts up significantly vs. 2019

Virtual Kidney Education aims to engage individuals and families who have diabetes, hypertension, early stage chronic kidney disease (stages 1–2) and chronic kidney disease (stages 3–4). The sessions will be hosted by a member of TKF staff and will include members of the kidney health care team: patient advocate, nephrologists, vascular surgeons, health educators, social workers, and dietitians.


